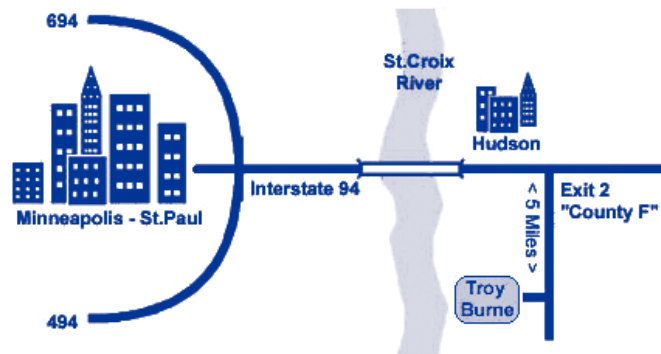
Transportation Services to and from home and work on one of our safe, clean, and dependable vehicles; or coordinated with public carriers.



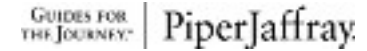

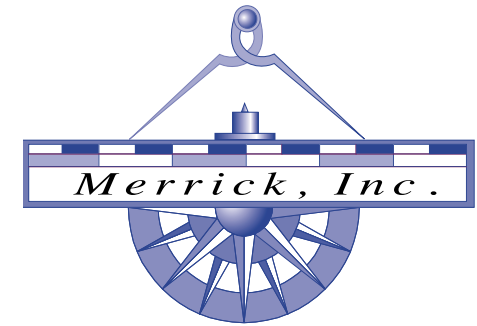
